## Membership Rules and Regulations

- Membership fees must be paid in full to receive member rates and to attend member-only functions.
- The Network Roster is for member use only and is published semi-annually.
- Members are prohibited from sharing the electronic roster with outside parties. Failure to respect membership confidentially in this regard can lead to expulsion from the WVWN.
- Once you confirm your attendance at a dinner meeting or other event, you are committed. If you have to cancel sometime after the preceding Friday at 4 pm (for a Tuesday dinner) or Monday at 4 pm (for a Wednesday dinner), you are welcome to “donate” your entrance fee to a friend so she can attend in your place. Please let your substitute know in advance that she will be charged the full admittance fee (\$30 or \$35) at the door, depending on whether she is a member or a guest. Confirmation of attendance for special events must be received by advertised deadline. Cancellation of attendance for special events must be received by advertised deadline.
- Members of the Network are not eligible to be guest speakers.
- Promotional opportunities for Members include: Member’s Spotlight, literature table at regular meetings, Round Robin introduction at most dinner meetings, and the donation of door prizes.
- The West Vancouver Women’s Network is a non-profit association. Financial statements are prepared on an annual basis and available upon request to members.
- Elections of members to the Executive are held annually in October. Members are eligible for all positions. Executive positions are on a volunteer basis. Term is one year. The Executive is not personally liable for debt or liability of the Network.
- The Executive welcomes ideas, queries or concerns expressed by the members.
